crisis. He also received the Mastership designation by the American Society of Clinical Pathology for his ground-breaking work in test utilization management.


While at the world renowned Cleveland Clinic, Gary held the following positions:

There are 50 cadets training in these units at 5:45 am Monday through Thursday. That dedication has resulted in the units winning several awards.



The JROTC units have preformed at home football games, school assemblies and other community events. October 25-27 members of the JROTC attended a weekend survival camp working toward a survival medal. Not an easy task as they must complete a 6 mile walk/run in two hours, cook food over a fire they build, orienteer from one point to another using only a compass, pace count and build an improvised shelter and sleep overnight in that shelter.
